The audience is invited to provide input as to how such problematic wastes can be addressed, including ideas for State-EPA collaboration to enhance the management of those wastes. Problematic wastes may include wastes that are:

- Subject to regulation but overlooked by generators;
- Pose very low risk in small quantities but large quantities of the waste pose a risk;
- Burdensome for the generator to determine if the waste is subject to regulation;
- Difficult to analyze;
- Only periodically subject to regulation; or
- A relatively new waste type.
