CERCLA & Brownfields

The ASTSWMO Brownfields Focus Group published their 128(a) Successes Checklist project this quarter. The checklist and definitions below are meant to summarize the work accomplished during the reporting period that is not captured by ACRES and PALS. It is not meant to be a comprehensive compilation unless defined as such but rather a “snapshot taken” during that period. The Focus Group realized that programs and needs vary from State to State (and Territories) and therefore accomplishments will also vary, so the Checklist is not meant to be a “to do” list or goal to complete a task to obtain a number in every box, but rather an improved manner to report accomplishments and to provide a means to easily summarize what is being done on a national level.

Board of Directors

At their July meeting, the ASTSWMO Board of Directors adopted a position paper on Federal Regulation of Coal Combustion Residuals (CCRs) that was jointly developed by the Hazardous Waste and Materials Management Subcommittees. The paper draws upon comments previously provided to EPA in recommending that any federal regulation of CCRs be under RCRA Subtitle D. The position paper is available on the ASTSWMO website. Materials Management

The MSW Recycling Task Force has recently updated its Commercial Sector Recycling Reference Sheets. The July 2014 update, which includes links to recycling resources for 12 sectors, is available on the Materials Management Policies and Publications webpage [here](#).

Tanks

The Tanks Subcommittee and its Task Forces released several resource documents this quarter. The Tanks Subcommittee published the Development and Implementation of State Tanks Core Programs (Tanks Core Report), which provides a summary and analysis of the costs of operating and maintaining the State UST programs. The Subcommittee also developed the LUST Trust Fund Fact Sheet, which summarizes current budget and guidance information specific to the LUST Trust Fund. The Trust Fund provides federal funding to support the U.S. EPA's, States', Territories', and Tribal LUST remediation and prevention programs. The LUST Task Force published two documents: the Lead Scavengers Survey Report documents how several State programs address the lead scavengers EDB and 1,2-DCA, and the Compendium of Emergency Response Actions at UST Sites updates the 2012 versions to provide 14 additional information sheets on emergency response actions that have occurred in States across the country. On August 20-22, 2014, the UST Task Force hosted the 2014 ASTSWMO UST Compliance and Prevention Workshop in Manchester, NH. Approximately 100 attendees from 39 States and Territories, U.S. EPA Headquarters and Regions, and private industry and organizations participated in the Workshop. Information from the meeting, including copies of presentations and video recordings of many sessions, will be available on the ASTSWMO website soon.

Federal Facilities

The State Federal Coordination Focus Group sent a request to all State and Territorial federal facility managers in August to gather information on their programs' procedures for evaluating protectiveness changes that may arise at closed federal facility sites. The information gathered from States will be used to develop an issues paper that will document how States ensure protectiveness at closed federal facility sites. The FUDS Forum Working Group held its first meeting on July 15-17, 2014, in Arlington, VA. A summary of the meeting and supporting documentation will be sent to all States when finalized. The State members will also reach out to all States for assistance in prioritizing issues the Working Group should address.
