ALL LARGE EXPENDITURES (GREATER THAN \$5,000) MUST BE APPROVED BY THE EXECUTIVE DIRECTOR (OR DEPUTY DIRECTOR IN THE EXECUTIVE'S ABSENCE) AND AN OFFICER OF THE BOARD OF DIRECTORS.

WHEN A CONFLICT OF INTEREST ARISES, THE REPORTING BOARD MEMBER OR STAFF MEMBER SHALL RESPECT THE DECISION OF THE EXECUTIVE COMMITTEE AND RECUSE HIMSELF/HERSELF FROM THE DECISION PROCESS AND NOT INFLUENCE ANY OTHER PERSON PARTICIPATING IN THE DECISION PROCESS FOR THAT ACTIVITY.
